

General Membership Minutes January 11, 2024, 10:00 am – 11:30 am

The mission of the Butler Collaborative for Families is to build a unified and integrated network of services by using a multiple-agency approach to break down barriers and strengthen the system of care for individuals and families of Butler County.

- I. Welcome: BCF Co-Chairs Becky Clouse and Linda Thoma- Meeting was called to order at 10:07
- II. Review and approval of the November 9, 2023, BCF General Meeting minutes- M/S/A
- III. Budget & Finance Committee Report: BCF Treasurer was absent, an update will be given at the February meeting.

- **IV. Featured Speaker:** Rebecca Maletto-Cornell is the Program Director/Manager for the **Foster Grandparent Program** of Southwestern PA, locally sponsored by Wesley Family Services.
 - a. Created in 1965 as part of the Red Cross. Currently a partnership with Americorp.
 - b. To qualify as a "foster grandparent" you need to be 55 or older and on a limited income. "Grandparents" are paid \$4/hour and these wages do not count against their supplemental income or possible housing allowances.
 - c. Grandparents are assigned to non-profit child-based agencies/service providers. (ex: preschools, daycares, after-school programs, and private schools.)
 - d. Grandparents give 1:1 support to children in the classrooms to help with redirecting, life skills, and basic academic support. They are an additional support to the paid staff in the classroom.
 - e. Grandparents must work at least 15 hours a week.
 - f. Data shows that there are improved skills and behaviors in the most high-risk category of children.
 - g. Over 90% success rate with children receiving help from a grandparent.
 - h. The elderly are also benefiting from the program by having a sense of purpose and calling in their life
 - i. Many are showing signs of improved mental and physical health by participating in this program
 - i. Children are going home with needs being met and behaviors are improving at home, as well as at school.
 - i. Parents are seeing the benefits of the program and they are supporting the grandparent by trying to improve parenting skills at home. (ex: teaming together to teach better manners)
 - j. Schools/agencies will interview the grandparent to make sure they are a good fit for their classroom. Volunteers will be trained through a rigorous program and clearanced before starting in a classroom.
 - k. The oldest "grandparent" to ever start was 92. She served until she was 102
 - I. The Foster Grandparent agency is looking for both volunteers as well as agencies to host grandparents in Butler County. The area is lacking in both volunteers and opportunities to serve.
- V. Member Spotlight: Ken Clowes is the Community Initiative Center Assistant at BC3 and the BCF Adult Representative: Hope is Dope
 - a. Ken talked about the Hope is Dope program and the education piece that is important to those in recovery and their families.
 - b. Ken talked about hope producing the same endorphins as opioids.
 - c. Brains can adapt and change through support and education for someone in recovery.
 - d. New classes are coming soon. There will be staff training to help learn the language of recovery, a recovery community class, and an intensive recovery class.
