With a mission to empower children with disabilities to live life to the fullest, Variety provides life-changing mobility and communication equipment to ensure our most vulnerable kids are no longer left out, left behind, or excluded. Variety focuses on mobility, communication, and inclusion for children and families in 59 counties in PA and 1 county in West Virginia.

- i) International organization, but started in the Pittsburgh region in the 1920's.
- ii) Provides life changing equipment to disabled children. Focus on bikes, strollers and voice systems
- iii) Medical supply company customizes the bikes for each child
- iv) Voice system supported with a partnership with the state, most plentiful funds for these items
- v) Partners with many agencies to raise funds to support the items so they are no cost for families.
- vi) Open to being a part of events and collaborating with other agencies
- vii) Over 100 pieces of equipment given out in Butler County
- viii) Intermediate Units and schools put in referrals for equipment, but individuals can also contact Variety directly.
- ix) Very generous income guidelines for qualifying families.
- x) 9 kids on the wait list for a bike/stroller in Butler County
- xi) 3-21-year-olds served with the equipment. Two-year-olds qualify for the voice systems
